PRIVACY AND DATA SECURITY

At Akin's Natural Foods your right to privacy and data security is our primary concern. That's why, when you visit akins.com, we will help you maintain control over your personal data on the Internet. Below are the guidelines we use for protecting the information you provide us during a visit to our Internet site at akins.com. This statement discloses the privacy guidelines for the Akin's Natural Foods website.

AKIN'S NATURAL FOODS ONLY ASKS FOR SPECIFIC TYPES OF PERSONAL INFORMATION

In a few areas of our Website, we ask you to provide information that will enable us to enhance your site visit, to assist you with technical support issues or to follow-up with you after your visit. It is completely optional for you to participate.

For example, we may request information from you to:

- Provide online feedback
- Participate in a promotional offer
- Subscribe to a newsletter or a mailing list

In each of the instances above, we may ask you for your name, e-mail address, phone number and address, as well as other similar "personal" information that is needed to register or subscribe you to services or offers (referred to herein as "Personal Information"). If we ever ask you for significantly different information, we will inform you. In the case of newsletters or mailing lists, you will be able to "unsubscribe" to these mailings at any time. Akin's Natural Foods only uses your personal information for specific purposes. The Personal Information you provide will be kept confidential and used by Akin's Natural Foods and its agents and contractors to support your customer relationship with us. Among other things, we want to alert you to product information, changes, special offers, and product promotions. Agents or contractors of Akin's Natural Foods who have access to your Personal Information are required to keep the information confidential and not use it for any other purpose than to carry out the services they are performing for Akin's Natural Foods on your behalf. Akin's Natural Foods may enhance or merge your non-personal statistical information collected at its site with data from other sites and third parties for purposes of marketing products and services to you.

PERSONAL INFORMATION AND CHILDREN

Akin's Natural Foods will not knowingly collect, use or disclose personal data from a minor under the age of 13 without obtaining prior consent from a person with parental responsibility (e.g., a parent or guardian) through direct off-line contact. We will provide the parent with (a) notice of the specific types of personal data being collected from the minor, and (b) the opportunity to object to any further collection, use, or storage of such information. Akin's Natural Foods abides by laws designed to protect children. Parent age data is collected to comply with COPPA (Children's Online Privacy Protection Act) regulations. The Akin's Natural Foods site is not intended for audiences under 13 years of age.

We may send you information about our various products and services, or other products and services we feel may be of interest to you. Only Akin's Natural Foods (or agents working on behalf of Akin's Natural Foods and under confidentiality agreements) will send you these direct mailings. If you do not want to receive such mailings, simply tell us when you give us your Personal Information. Or, at any time you can easily stop receiving further marketing from Akin's Natural Foods by contacting

us and requesting your removal from our mailing list.

AKIN'S NATURAL FOODS WILL NOT DISCLOSE YOUR PERSONAL INFORMATION TO ANY OUTSIDE ORGANIZATION FOR ITS USE IN MARKETING WITHOUT YOUR CONSENT.

Your personal information or your order and the products you purchase will not be given or sold to any outside organization for its use in marketing or solicitation without your consent. Your Personal Information may be shared with agents or contractors of Akin's Natural Foods for the purpose of performing services for Akin's Natural Foods for your benefit.
